**4. To confirm the minutes of The Panel meeting held on 12<sup>th</sup> July 2017.**

It was RESOLVED that the minutes were a true record of the meeting.

**5. Matters Arising.**

(i) No. 048 – DOVE Media Hub. No news as yet as to the success of the application to the Welsh Government RCDF.

(ii) No. 050 – Woodland Development Project with NPT CBC.

Council are to meet Catrin Evans of NPT Biodiversity at the 13<sup>th</sup> November monthly meeting with regards to a start date.

**6. To consider the following applications.**

(i) No. 051 - Dulais Divas - iPad, banner, music.

The application contained items for room hire and transport which were considered to be ineligible. It was unanimously agreed that the eligible items amounting to £1,947.47 be recommended for approval by NPT CBC.

(ii) No. 052 - Onllwyn AFC - Tractor.

It was unanimously agreed that this application in the sum of £14,995 be recommended for approval by NPT CBC.

(iii) No.053- Dulais Valley Rugby – Kit for under 12s and under 14s

It was recalled that a grant had been given previously (No.022) for the Under 12s. It was decided that the team organisers be asked to re-submit the application for the under 13s and under 14s. Once this is received the clerk to email Panel members with the revised details seeking their approval.

Postscript.

The revised application was approved by Panel members in the sum of £2,536 and forwarded to NPT CBC for approval.

(iv) No. 054 - Banwen Gardening Club - Tools, strimmer, container.

The application contained a sum for tools which was considered to be ineligible. It was unanimously agreed that the eligible items amounting to £4,692 be recommended for approval by NPT CBC.
